<p>(a) Comply with the provisions of the Immigration Act and any regulations or notifications thereof, in force in the Kingdom of Bhutan;</p>	
<p>(b) Be responsible for the cost of his or her stay in the Kingdom and repatriation thereof, if necessary;</p>	
<p>(c) Deposit the Sustainable Development Fee to the Department and bear the applicable fines and penalties as may be imposed, if it is established that the guest is a tourist;</p>	
<p>(d) Ensure that the guest will not engage in any act or form of employment paid or unpaid, or in any business, or any other activity, which in the opinion of the Department, is detrimental to the security, reputation and wellbeing of the Kingdom;</p>	
<p>(e) Ensure that the guest shall not seek to stay beyond the approved visa duration or 30 days, whichever is less;</p>	
<p>(f) Ensure that the guest will not speak or act against the King, the Country and the People of the Kingdom of Bhutan.</p>	
<p>(g) In the event of misuse, I understand that I will not be allowed to invite any personal guest for 5 years and will also be imposed applicable fines and penalties.</p>
